Sanitation Report

- 1. 52 Vernon Avenue Solid Waste Complaint Notice of Violation was sent the owner of the property had the area cleaned up
- 2. Rite Aid Recycling Audit was completed
- 3. 11 Michael Court had a complaint of rats were running all over the street. Near her house was a nest of baby rats. They took the nest and placed in the adjoining property which is vacant and filled with heavy brush. The owner of the property was contacted and they agreed to cut down the high brush. Confirmed that the area was cut down and they were putting traps out.
- 4. Several food establishments; Hamburg Fire Department, Hamburg Elementary School, Road Runner and Seven Eleven were inspected and were satisfactory. Hamburg Recreation applied for and was approved for a temporary food license.
- 5. Ferrell Gas- 1 Wallkill Avenue had an incident, Haz Mat was called in. Clan up and following sampling was performed on the site.

- 7. Complaint Vacant land behind Kirkwood had become an area where bears were bringing all the garbage. The owner of the property was contacted and sent a crew out to clean the entire area up.
