Individual Cases

73 Vernon Ave – waiver of service fee

The Board discussed the letter received from Lisa MacMoyle, Administrator of the Estate of Lenard E. Rink, asking that the \$100.00 service fee be waived due to legal issues on his accounts with regards to his death. It took time for the legalities on the estate to be settled and correspondence to be received and although the bill was received and paid, Ms. MacMoyle is asking the fee be waived due to this. The Fairways at Wallkill River

The Borough received correspondence from John Ruschke regarding The Fairways and Well 1A. Paperwork will have to be submitted by Mr. Jackson to the State before he can turn the well over to the town, but Mr. Ruschke is on top of the situation. This letter is our notification of what was sent to Mr. Jackson.

Councilman Garrett asked Mr. Schneider if Mr. Kastner uses all three wells, and he answered that yes, he changes them up so that all three wells are "exercised".

SCMUA-Actual Annual Charge FY2015 and Quarterly Estimated Charge FY2016; SCMUA Sewage Treatment Services

SCMUA will be issuing a credit to Hamburg in the amount of \$24,233.00 as the actual volume of sewage that we sent through the system was not as great as original calculated. This is a great reflection on maintaining our system and keeping our sewer flows low.

Chris Fitzpatrick asked if the Board could get a breakdown on the Department of Public Works, what is spent and on what. Mayor Marino said that our CFO would be able to give that record sometime in March when the budget is done.
