Peter McArthur gives an overview of the application. In 2009 he came before the board for an extension, which expires in October 2011 and he is here today to ask for a preliminary site plan extension and a use variance extension. DOT approvals are pending. All paperwork has been filed with DOT as of last month. Even though the permit extension act does not cover this application because it is located in the planning zone this application calls for the type of relief that the act stands for.

Tom Watts – talks about property appearance and general maintenance. He wonders if by granting approval there can be a condition about the cleanup of the property.

Attorney McMantis states that it is something that can be done.

Mayor Marino does not want to see it as a condition of the extension. These are tough times for everyone right now.

Attorney McMantis states on the record that the use variance granted is particular for a pool store. If the property is sold any use, other than a pool store of the same size would have to submit a new application.
