CASH MANAGEMENT PLAN

WHEREAS it is in the best interest of the Borough of Hamburg to earn additional revenue through the investment and prudent management of its cash receipts; and

WHEREAS P.L. 1983, Chapter 8, approved January 18, 1983 is an act concerning the Local Fiscal Affairs Law and amends N.J.S.A. 40A:5-2 and N.J.S.A. 40A:5-14; and

WHEREAS this requires that each local unit shall adopt a cash management plan.

NOW, THEREFORE, BE IT RESOLVED, that the following shall constitute the Cash Management Plan for the Borough and the Treasurer shall deposit and manage its funds pursuant to this plan:

Definitions

- Treasurer shall mean the Treasurer of the Borough of Hamburg
- Fiscal Year shall mean the twelve-month period ending December thirty-one.
- Cash Management Plan shall mean that plan as approved by resolution.

Designation of Depositories

At least once each fiscal year the governing body shall by resolution designate the depositories for the Borough of Hamburg in accordance with the N.J.S.A. 40A:5-14.

Audit Requirement

The Cash Management Plan shall be subject to the annual audit conducted pursuant to N.J.S.A. 40A:5-4.

Authority to Invest

The governing body shall pass a resolution at its first meeting of the fiscal year designating the Borough official(s) who shall make and be responsible for municipal deposits and investments.

Investment Instruments

The Treasurer shall invest at his discretion in any investment instrument as approved by the State of New Jersey in accordance with N.J.S.A. 40A:5-15.1.

Records and Reports

- The Treasurer shall report all investments in accordance with N.J.S.A. 40A:5-15.2.
- At a minimum the Treasurer shall:
 - Keep a record of all investments.
- Keep a cash portion record which reveals, on a daily basis, the status of the cash in its bank accounts.
 - Confirm investments with the governing body at the next regularly scheduled meeting.
- Report monthly to the governing body as to the status of cash balances in bank accounts, revenue collection, interest rates, and interest earned.

Cash Flow

- The Treasurer shall ensure that the accounting system provides regular information concerning the cash position and investment performance.
- All moneys, shall be turned over to the Treasurer and deposited in accordance with N.J.S.A. 40A:5-15.
- The Treasurer is authorized and directed to invest surplus funds of the Borough of Hamburg as the availability of the funds permit. In addition, it shall be the responsibility of the Treasurer to minimize the possibility of idle cash by depositing the monies in interest bearing accounts wherever practical and in the best interest of the Borough of Hamburg.
- The Treasurer shall ensure that funds are borrowed for Capital Projects in a timely fashion.

Falcon Ridge Sewer Interconnection Project, (NJEIT) Contract 1-the low bidder was PM Construction Corp. at \$212,985.00, and Mr. Ruschke has worked with them previously. The paperwork can be in place for an early spring start and he recommended to the Council to award this bid to PM Construction Corp., pending DEP approval, Attorney review, and certification of funds. Orchard Street Drainage Improvements (NJEIT) Contract 3- the low bidder was John Garcia Construction Co. Inc. at \$310,573.00, which was substantially lower than the engineer's estimate. Although John Garcia has done previous work in town, he is always late beginning the project but he is competent and does complete the project. Mr. Ruschke does recommend to the Council awarding this bid to John Garcia Construction Co. Inc. pending DEP approval, Attorney review, and certification of funds.

Heritage Lakes Sewer Pump Station Improvement (NJEIT) Contract 2- Mr. Ruschke explained to the Council that before this bid can be awarded, there is one issue to resolve concerning the registration paperwork and the public contracts law. Liberty Inc. was the low bidder but registered as Liberty Corp. and now the second low bidder is protesting, so the paperwork just has to be cleared before this can proceed. He will keep the Council informed.

As Mayor Marino does not want to have to borrow more money for other projects down the road, he asked CFO Amy Maronpot for confirmation on the years of pay down on the NJEIT loan (20 years). He also asks if we are able to pay the loan down faster without a prepayment penalty and Ms. Maronpot confirms that we are able to do so.
