John Haig – Fire Chief – Mr. Haig stated that the helicopter is doing a landing drill to teach all and in case there are no officers are present also. With regards to the fund drive, the DOT will regulate the times on Friday night, we just submit the application and they will get back to us. Chief Haig discussed FerrelGas with the Council. His concerns were: if the driver fell at night while delivering, no one else would be around and he would be off-loading, he would not be able to hit the shut off valve. If this were during the day, a certified technician would be with the driver.

Mr. Haig also inquired about the baseball fields at the new rec fields. Wallkill Valley would like to use them as secondary fields. Mayor Marino stated the fields would not be ready until May; rules and regulations also need to be discussed before any use.

Bridget Walsh – 2 Main Street – inquired of the Council as to if a decision has been made about the parking in the municipal lots. Councilman Kelly said that he did walk the area, spoke to Jodi at Wilcox Press and she stated that she would allow parking behind her building as long as liability papers were signed. Ms. Walsh again reiterated that there is not enough space in the back to do what Jodi is suggesting and there is an easement and parking is not available in the easement. Councilman Kelly again stated that if we make exceptions with her then the Council must make them with everyone else that comes before them. Mayor Marino asked when Ms. Walsh last new tenant moved in and was answered January 15, 2011.

Sheila Frayko – School Board Liaison – said that the school budget increase was 7.4% Motion by Councilman Law, seconded by Councilwoman Oehler to close to the public. All in favor.
