US Gov Bid - 95 Ambulances - \$6450.00 and 2006 Ford Trailer \$3000.00. Monies have been received. Mayor Marino stated that the ambulance and trailer were put up for bid on GovBid, bids received, sold, and money received for the two.

On Main Street, there have been complaints of speeding on the street, which will be addressed, but also business owners would like to see better signs showing Main Street shops. Councilmen Barr and Garrett will work on those signs.

FIRE COMMISSIONER - OEM

Fire Department Application - Richard Padgett, background check was completed.

Councilman Barr stated this application will be tabled for the time being as the residency requirements have not yet been be fulfilled.

EMS Report Calls for 2013

EMS Report Calls for January 2014

Council reviewed the submitted report of EMS calls for 2013 and January 2014, noting that there were 77 mutual aid calls alone into Hardyston for 2013 and 10 for 2014. Councilman Sena questioned what time of day these calls took place, as they have Sparta covering their town. Councilman Barr said that most of the calls are generated from Crystal Springs. Councilman Sena just wanted to make sure that it was brought to Hardyston's attention should we enter into negotiations with them. Councilman Barr also stated that Hardyston Police come to Hamburg to help out on calls so each town is always helping out each other. Councilman Garrett added that there are two paid ambulances in Sparta.

OEM Request - Purchase of enclosed trailer

Council is in receipt of a request from Keith Sukennikoff, OEM Coordinator, to purchase a 6X12 enclosed

trailer for various uses for OEM, but could also be used by the Police for their equipment should they need to close off roads, etc. It would be purchased using money from the sale of the old OEM trailer, so the money will not be coming out of the OEM budget. This is also under State Contract and the approximate purchase price would be \$4274.50, probably slightly higher as this was quoted in November 2013.

Motion by Councilman Barr, seconded by Councilman Garrett to approve the purchase of the trailer using FEMA money at a purchase price of approximately \$4274.50 under State Contract. All in favor.

Mayor Marino stated that it would be probably be stored by the Police Station for convenience purposes.

POLICE COMMISSIONER

Motion by Councilman Barr, seconded by Councilman Garrett to open the meeting to Police Director Wayne Yahm. All in favor.

Police Monthly Report for December 2013 and January 2014

Monthly Report December 2013

The December 2013 monthly report for the Police Department showed 565 calls of service, including 10 arrests, 10 motor vehicle accidents, and 35 motor vehicle summonses issued.

Monthly Report January 2014

The January 2014 monthly report for the Police Department showed 616 calls of service, including 7 arrests, 11 motor vehicle accidents, and 32 motor vehicle summonses issued.

Director Yahm speaks about the Hamburg School regarding the one way traffic / road closure during school hour's signs. He said the signs are being researched and the wording with regards to delayed openings / early dismissals especially.

DARE is being changed to DARE-NJ Program and will be starting in March at the school and will run for 10 weeks thru to May. Sergeant Nichols will be going for the training.

Memorandum from Wayne Yahm regarding purchase of 2014 Ford Police Interceptor Utility Base Vehicle.

Council members have the information for the new patrol vehicle and it is the recommendation to go with a 2014 Ford Police Interceptor Utility Base Vehicle. The said package would also include a computer and radio installation, be "Police Ready" for a total package of approximately \$38,184.00. The only item that will be needed will be a video camera. This is under State Contract. The markings and decals will have to be put on. Mr. Yahm said that a game plan for the financing will be needed and nothing will be auctioned off. When asked, Mr. Yahm also stated that the surrounding towns are using these SUVs and getting away from the sedans. Councilman Sena asked about the possibility of leasing. Councilman Garrett asked about the mutual aid of police into Hamburg from Hardyston and Franklin. Mr. Yahm replied that it was several times a week and reciprocal- and pretty even.

Council members decided to wait until Finance could be brought into the discussion.

Motion by Councilman Barr, seconded by Councilman Garrett to close to Director Yahm. All in favor.

HISTORIC COMMISSION / HISTORIC SOCIETY

Councilman Barr informed the Council that the Designation of Main Street was tabled due to concerns of the residents and more research will be done on it.

Councilmember Krasnomowitz advised that there were 12 permits issued, 1 certificates of occupancy, and 9 certificates of approvals with a total of \$1541.00 collected in fees for the month of December.

4. INSURANCE

Statewide Insurance 2014 Assessment.

Statewide Insurance notification of 2014 Fund Year Coverage Change.

Councilman Krasnomowitz stated that the insurance costs for the Borough for the upcoming year 2014 in the amount of \$125,688.38, which is a \$3616.38 increase over last year, which is a minimal increase. Councilman Krasnomowitz also stated that there are no decreases in coverage for the town from last year.

COUNCILMAN BURD

SANITATION AND RECYCLING

The tonnage reports are being sent in, with a deadline date of March 1st. The town receives money for the amounts that are submitted.

There is a Dr. Pepper and Snapple grant-Keep America Beautiful and Marguerite Nemeth is submitting this grant to obtain recycling retainers- due the end of February.

Councilman Burd asks of the Council their ideas of clothing bins being placed in areas of town. The company would pay us according to how much is collected. Mayor Marino said that he would be concerned that it would become a garbage dump. Councilman Garrett said that a location would be a problem - that a lot of Fire Departments are involved in doing this but we don't have a location to do it. Council members agree.

Councilman Burd presented information regarding eCIVIS, a company that acts as a search engine for all grants available and upon an agreement executed with towns, will forward same information on a daily basis. He stated that he knows there are a lot of grants out there for us to receive money to better the town and we could make a deal with the grant writer of the company, but this would cost additionally. Each department would be responsible for writing the grant that would pertain to their department. The cost is \$495.00 per year and a 3 year contract is needed. More information and research is needed before contracting with them, so there will be further discussion.

BOARD OF EDUCATION

Councilman Burd relayed that there is a vacant seat on the Hamburg School Board as Donna Mangine is leaving. There was asbestos found in the wooden floor of the gym, so unfortunately a company will now have to be brought in to do core samples, etc., turning the project into up to \$200,000.00 because of this. On the Wallkill Valley Board, the superintendent is leaving and a special meeting is being held on February 12th to discuss hiring.

Council is in agreement. Motion by Councilman Garrett, seconded by Councilman Krasnomowitz to have Hardyston perform maintenance on the recreation fields at no cost to the Borough. All in favor.

Estimate from Hayenhjelm Electric Co. LLC regarding estimate for Roadway Sign.

An estimate from Hayenhjelm Electric was submitted for the wiring of the sign at the municipal building in the amount of \$1600.00.

Councilman Garrett also discussed the masonry work for the sign and had three quotes for the base: from Engineer John Ruschke at \$6100.00; Contractor Dennis Fitzgerald submitted a quote of \$3140.00 and Tri-County Masonry submitted a quote of \$3200.00. It was the recommendation of Councilman Garrett to accept the quote of Dennis Fitzgerald.

Councilman Garrett presented the annual contracts for Gerald Kastner as Water Superintendent and Chief Transmission Operator for 2014 and the contract for Mike Schneider as Assistant Transmission Operator and Plant Operator for 2014, stating these contracts will be sent to Finance for review and financial updates. The Tax Collector's report for December 2013 showed a total of \$229,452.22 being collected.
