PRESENTATION

Mayor Marino made a presentation of the 2014 Junior Citizen Award to Miss Jessica Haig, who is involved in activities in the Hamburg School, the Girl Scouts, cheerleading, Jr. Police, fundraisers, and helps her mom at home. She was presented with a certificate from the Council and a gift certificate from the Recreation Commission.

EMEX - Mr. Mike Stoller will give a presentation on EMEX Power.

Motion by Councilman Garrett, seconded by Councilman Law to open the meeting to Mr. Mike Stoller of EMEX. All in favor.

Mr. Mike Stoller discusses with the Council the DCA approved energy savings that he is offering the town the opportunity in which to be involved. There are currently 130 municipalities that have taken advantage of this energy procurement. Mr. Stoller has reviewed two years of our information and believes the auction can save us money on our bills. It is a live auction that takes place while we are watching on the internet and EMEX is on the phone with us. JCP&L owns the lines but the winning bidder would be servicing the energy. EMEX receives a commission from the winning bidder. Councilman Garrett asked what would happen if the power went out. Mr. Stoller answered that JCP&L would repair the lines as they own the lines; we just get our energy from another company. EMEX would contact us before the contract runs out so that we could either return to JCP&L or do another bid. Attorney Clemack would like to review the contract. Mr. Stoller stated that there is no contract with EMEX. This is done by resolution. There is an auction tomorrow, June 3rd at 11 AM, and the town could pass a "trigger resolution" to move ahead with the auction, having the clerk, CFO, or whomever to sign the papers. Council discusses this, and seeing how the Mayor would not be in town before the papers need to be sign, discuss having the clerk sign. Motion by Councilman Barr, seconded by Councilman Sena to accept the resolution as offered by EMEX for the energy savings for the town via live auction for electric. All in favor. Motion by Councilman Garrett, seconded by Councilman Burd for the Borough Clerk Doreen Schott to sign the contract from the live auction based on the recommendations of EMEX. All in favor.

Mr. Stoller and Council discuss the natural gas energy part of the auction and decide since the situation with the coal, etc. is so volatile; they will also go with the energy auction also. Motion by Councilman Burd, seconded by Councilman Sena to accept the resolution as offered by EMEX for the savings for the town via live auction for gas. All in favor.

ATTORNEY HOUR:

E-Ticket with GTBM

Motion by Councilman Barr, seconded by Councilman Law to open the meeting to Director Yahm. All in favor.

Director Yahm discusses the slide for E-tickets. This is a device in which the officer will slide the driver's license and it reads all the information (barcode) on the license. It will add an extra \$2.25 per ticket, bringing the cost to \$8.63 - without it, the cost is \$6.06. After 800 tickets are written, the cost goes down to \$8.11. Councilman Barr asked how much does the town receive from tickets. Mr. Yahm stated that the court realizes around \$56,000.00 a year. Councilman Barr also asked if it will simplify the court work and Mr. Yahm answered yes, along with the Police Officer's time and data entry time, including the court. Councilman Sena discussed the tickets that get thrown out or pleaded down. We would still have to pay for them, Director Yahm said yes, but the officers would like this; this is what a lot of the other departments are also going with.

Director Yahm said he applied for and received a grant for new AED's but may still be able to get them through Newton Hospital at a lesser cost.

The new patrol car is at the dealership and will go to Geddis for the sign painting afterwards. Officer McNulty should be back by the end of June. Narcon will be discussed in Executive Session as advised by the Prosecutor's Office.

Councilman Krasnomowitz compared the construction report from the previous month and stated that it was encouraging as the numbers did grow.

BOARD OF EDUCATION

Councilman Burd informed the Council that graduation will be held on June 19th. He also said that it now costs over \$21,000.00 to educate a child in Hamburg School. There is an enrollment of 276 students, which keeps going down over the past few years, and that's what makes it so expensive. All bids were rejected for the gym floor as remediation of the asbestos was not included in the bid, so it will be going out for re-bid.

COUNCILMAN LAW

1. RECREATION

The Miss Hamburg, Little Mr. / Miss Hamburg Contests will be held on Sunday, June 8th at the School gym at 1 PM. Hamburg Day will be August 24th beginning at 12 noon.

2. COURT

Councilman Law said the AOC will be inspecting the Court at the end of the month and the Judge will be out for a few weeks due to surgery.

COUNCILMAN GARRETT

1. BUILDING AND GROUNDS

Farmside Landscape & Design Proposal for Perennial Plantings front of Municipal Building. Councilman Garrett presented a proposal from Farmside for a planting in front of the municipal building with perennials in the amount of \$860.00 for materials and labor.

Motion by Councilman Garrett, seconded by Councilman Law to accept the proposal from Farmside Landscape & Design for Perennial Plantings for the front of the Municipal Building in the amount of \$860.00. All in favor.

Councilman Garrett said the work on the meeting room ceiling will begin on June 4th, with the old ceiling being taken down. On the 9th the new sheetrock will be put in, but either new fluorescents or the same lights will be put back in as high hats were over \$8000.00 to have installed.

The trees to block the Limekiln Road residents from the Pavilion Area were discussed. Councilman Garrett will contact Ken Nelson about the trees and the planting of them, how many are needed, etc. Councilman Barr mentioned that "Max is Back", (garden place), has the 6'arborvitaes trees for \$40.00 each.

3. BOARD OF PUBLIC WORKS

BPW improvements are going on this year and while they are doing improvements, they are watching the spending also.

COUNCILMAN SENA

1. FINANCE / TAX DEPARTMENT

The Tax Collector's Report for April 2014 showed a total of \$541,396.16 being collected. Motion by Councilman Sena, seconded by Councilman Garrett to accept Resolution to redeem third party tax sale certificate #13-003 in the amount of \$2813.79; and Resolution to redeem third party tax sale certificate #13-006 in the amount of \$2252.02. All in favor.

2. ROAD DEPARTMENT

Councilman Sena relayed the red mason dump truck was received on May 29th and everything was in order with the truck. The Road Dept. Foreman is working with Geddis Sign for the signage on the truck. The brake parts on the old OEM truck are difficult to find and obtain. The Road Dept. now consists of 3 full time and 3 part time personnel. The foreman would like to hire 1 part-time person for summer to cut the grass at the park.

Councilman Sena said that Jennings Road was in bad shape and after discussion, will contact John Ruschke and finance about the funds to pave the road for the summer. Councilman Garrett

mentioned paving it when the State is in the area doing their summer project. John Ruschke will be consulted.

BOARD OF HEALTH 3.

The next meeting will be in July. Councilman Sena said The Red Cross and the Board of Health will have a booth at Hamburg Day.

PUBLIC PORTION:

Motion by Councilman Barr, seconded by Councilman Barr to open the meeting to the public for any questions or comments they might have with regard to the good and welfare with the Borough. All in favor.

Joyce Oehler - EMS Captain - asked of the Council permission to take one ambulance on Goochie's Garlic Run on Wednesday, June 18th, stating that there will be another ambulance in town. Council did not see an issue with it.

Joyce Oehler - 39 Hamilton Street Resident - stated that, in speaking with some of the cops, they are on by themselves and are running ragged, and she feels that it is a safety issue; asked if any new officers will be hired. Director Yahm stated that the manpower has stayed the same and their attitude is fine. He will discuss the issue with Mrs. Oehler privately.

Mike Schneider - Road Dept. Foreman - when asked by Mayor Marino, Mr. Schneider said that he checks the fire hydrants every six months.

Motion by Councilman Barr, seconded by Councilman Garrett to close to the public. All in favor.

Motion by Councilman Barr, seconded by Councilman Law to permit EMS to take one ambulance out of town on the Goochie's Garlic Run on June 18th, as long as there is another ambulance in service for the town. All in favor.
