#### PRESENTATION: Patrolman Jason Tangorra

Mayor Marino stated that the Hamburg Police Officers received the Narcan training and on October 11, 2014, Officer Jason Tangorra was the first person on the scene of a possible overdose and administered the Narcan and possibly saved this person's life. He said there is a major drug problem within the county and if we can help at all save our residents, then we should try. Mayor Marino said Hamburg had the best Police Department in the County.

Police Director Yahm stated that it was not just one group that is affected but all, and that it was a great program.

Mayor Marino presented Patrolman Jason Tangorra with a plaque.

Mayor Marino informed the Council that a Shared Services meeting for Hardyston was held and it was a good meeting that involved zoning, the phone system, the interconnection, and EMS coverage. He said, with regards to zoning and the phone issues, they will need to be resolved further. Our Water Superintendent is not favorable of the interconnection but for the present time, the engineers will get together and talk. Hardyston was very responsive to talking about budgetary concerns with regards to our EMS coverage in their town as they are having problems with coverage. They would like to have a dollar amount from us for compensation to present to their Council. There will be more discussions on this matter.

#### 2. POLICE COMMISSIONER

#### **Monthly report October 2014**

The October 2014 monthly report for the Police Department showed 615 calls of service, including 7 arrests, 14 motor vehicle accidents, and 86 motor vehicle summonses issued.

Director Yahm said that a lot of the training is done through the "NJ Learn" on the computer at the station. On Wednesday, November  $5^{th}$ , the bridge at the trestle will be worked on, between the hours of 9 AM - 2

#### PM. Signs have been out.

The new officers are working on their own now.

The E-Ticket is up and running and the officers love it. It is not in the Durango as this car needs a new computer at a cost of approximately \$3000.00. As per the CFO, hopefully the money will be available next month.

Councilman Law asked how many miles were on the Durango and Mr. Yahm answered about 60,000 and it was in good shape. Councilman Burd asked what the average was. Mr. Yahm couldn't give a specific answer as it really depended on idling, starts and stops, etc. He stated that the car had good maintenance upkeep.

Councilman Garrett asked how many E-tickets were written and Mr. Yahm answered 20-25 as the program was installed in the middle of the month. He also asked, concerning the trestle, how the officers are scheduled to work it. Mr. Yahm replied the full time officers are given the opportunity first, and then the special, and then it goes outside the department.

Councilman Law inquired about the 90 hours overtime. Mr. Yahm stated that it was due to training, sick time, and arrests. Now that all officers are on their own, it should go down.

Mayor Marino asked if the alarms were working and Mr. Yahm answered yes.

Councilman Sena asked if Mr. Yahm had heard about oversized vehicles using Mulberry and State Streets as "turn around" streets, coming out of the Mobil gas station, as they are not able to make a left turn onto Rt. 23, they make a right onto Rt. 517, then onto Mulberry, then State, then back onto Rt. 23. Mr. Yahm had not heard about it but will check on it.

Mr. Yahm also informed the Council that he had kids on community service paint over the graffiti on the Gingerbread Castle.

Councilman Garrett reviewed the quotes for the generator for the EMS building. There is a quote for the labor to hook up the generator in the amount of \$6910. from Hayenhjelm Electric.

Council is in receipt of two quotes – from GenServe in the amount of \$13,363.00 and from FM Generator Power Systems in the amount of \$13,920.00. After discussion, Council members decide to go with GenServe.
