MAYOR'S AGENDA:

1. Travel Advisory Directive

Mayor Marino advises that all employees were given a directive regarding the Travel Advisory put into place from the Governors' office. All directives were signed and acknowledged.

2. 16th Annual Hamburg Fire Department Golf Outing

Mayor Marino advises that the Hamburg Fire Department will be holding its 16th Annual Charity Golf Outing on September 28, 2020. Every year the Borough gives a donation and the Mayor requests the same this year.

Motion by Councilmember Garrett, seconded by Councilmember Krasnomowitz to a donation of \$100.00 from the recreation fund to the Hamburg Fire Department Annual Golf Outing. All Councilmembers present in favor.

3. Shared Service Agreement - Recreation Field Coordinator

Mayor advises that we have from Hardyston Township a Shared Service Agreement for a Recreation Field Coordinator. With the closing of the Littell Center Hamburg and surrounding towns still have the sports teams and necessary scheduling of games. The same individual who performed these duties under the Little Center will be continuing to handle all the scheduling of sport activities. The contract will run from July 1, 2020 thru December 31, 2022 at a cost of \$8,750.00.

Motion by Councilmember Law, seconded by Councilmember Krasnomowitz to approve the Shared Service Agreement for Recreation Field Coordinator. All Councilmembers present in favor.

4. Hamburg Garage Sale

Mayor advises that this is the time when the town usually plans a date for its annual town-wide garage sale. Following suit of other towns and at the recommendation of the Office of Emergency Management it is recommended that it not be held this year due to covid-19. Councilmember Burd advises that he agrees it should not be a scheduled event at this time. Motion by Councilmember Garrett, seconded by Councilmember Law to not schedule the annual town-wide garage sale for this year only. All Councilmembers present in favor.

5. Bid Results

For information, the Borough held a sale of surplus items on July 17, 2020. Items were the 1991 International Fire Truck, 2001 International Ambulance and the 2013 Chevy Ambulance. One bidder attended; they came in low with one bid but asked if they could counteroffer their first offer. Attorney advises that the town could negotiate with the one bidder. All three vehicles were sold for a total cost of \$37,700.

6. Covid-19 Update

Mayor advises that we are still following the state and federal guidelines, water reading and meter replacements are still on hold. The Land Use Board meeting is cancelled. He advises that should any board have an emergency situation they can hold remote telephonic meetings as we have been. The September 9th (Wednesday) meeting of the Hamburg Mayor

and Council will be held via telephonic.

7. Hurricane Isaias

OEM advises that the town is making preparations for the anticipated hurricane. The road department is making sure the catch basins are free of debris to help minimize any flooding there may be.

- 8. Agenda Correspondence #9 Mayor advises that he would like all members to review Correspondence #9 Resolution from Newton regarding Separate Taxation to the Municipalities that Utilize the Sussex County Dispatch Services". He would like this to be presented on the September agenda for discussion
- 9. Mayor advises that there was a recent break in at one of the town residents while they were away. He advises the police director to see that patrols are increased within the town

10. Purchasing Procedures

Mayor reminds everyone that the CFO put out Purchasing Procedures (memo July 21, 2020) that need to be adhered to. All department heads and supervisors should familiarize themselves with the procedures. He notes that there may be times when emergencies do arise and at those times payments will be added

Statewide Insurance – Loss Control Visit – Councilmember Krasnomowitz discusses the Loss Control Service Visit letter dated July 3, 2020. Visit went well, most issues were addressed, The Green Acre Park issue will be addressed.

COUNCILMEMBER OFHLER

Letter of resignation Tara Scrittore – Mayor Marino advises that Tara Scrittore has submitted her letter of resignation from the Recreation Commission. Motion by Councilmember Garrett, seconded by Councilmember Krasnomowitz to accept the resignation with regret. All Councilmembers present in favor.

Fire Department Application – Patrick Lukacsko – CAIR, Medical and Background check completed. Motion by Councilmember Burd, seconded by Councilmember Sena to approve the member ship of Mr. Patrick Lukacsko to the Hamburg Fire Department. All Councilmembers present in favor.

Councilmember Burd advises that he received from Hamburg School the NJ State Guidance Plan for the opening of Hamburg School. The school will reopen on September 3, 2020 with half day classes 5 days a week and will be in compliance of COVID-19 guidelines. Mayor Marino advised he would like Councilmember Burd to participate in the remote meetings

COUNCILMEMBER GARRETT

Property Maintenance 32 Vernon Avenue- Councilmember Garrett advises that he has notification from the zoning officer that the property has been abandoned, he was unable to contact the owner

on file. The property has not foreclosed as of yet. He is requesting permission for the Hamburg DPW to go in and cut the grass. Mike Schneider, Foreman, DPW submitted a Time and Cost Estimate in the amount of \$1350.00, this amount would then be put as a lien on the property. Motion by Councilmember Garrett, Seconded by Councilmember Krasnomowitz to authorize the maintenance of the property by town officials after Attorney Clemack speaks to the zoning officer. Mayor briefly advises that another issue 55 Mulberry is being addressed. They are going to meet with Councilmember Garrett, Road Foreman Mike Schneider and possibly use some of the millings from the Mulberry Paving Project to address the driveway access issue.

Councilmember Garrett gives an update of the concerns of wells and water levels, other areas are setting water restrictions in place; Hamburg's water levels are in great shape and we will not be implementing water restrictions at this time.
