Everything is all set for the event. Joyce suggested putting a flyer advertising the event at a few businesses around town.

Hamburg Day – September 9th

Paula relayed we should be hearing from Friendly’s ice cream shortly as everything has to go through the corporate offices and takes time. Kathy will send an email to Recycling to see if they are doing a vendor table. Rec has only received a few vendor applications back but it is still early, a lot waiting to see what the weather will be like for that day. There has been no commitment from the Fire Dept. as to the purchase of the food. Ron Garrett, Jerry Youkon, and Mike Schneider have all committed to cooking for the day. Members discuss different options for the purchasing of the food plus condiments should they have to purchase them. Since they are unsure of where they will purchase from and how much more it will be, they decided to go higher than what the food costs usually are.

Motion by Paula Marino, seconded by Suzette Villagomez to purchase food up to \$600.00 for Hamburg Day. All board members present in favor.

Since recreation does not have a meeting in August, members discuss having an extra meeting to discuss last minute preparations for Hamburg Day, switching July’s meeting to August, but decide to leave it as is.

Members talk over different options for doing so, all thinking it would be a good idea, but since there is a lack of members to handle this, it will be discussed more and possibly done at another time during the year or at next year’s Hamburg Day.
