

AN ORDINANCE AMENDING CHAPTER 209 -  
WATER - OF THE CODE OF THE BOROUGH  
OF HAMBURG COUNTY OF SUSSEX, STATE  
OF NEW JERSEY TO MODIFY WATER RATES

Ordinance #08-2013

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 209 - WATER - of the Code of the Borough of Hamburg, is amended as follows:

1. Statement of Purpose: Revenues under the existing rates system are not sufficient to cover costs. Accordingly, a five per cent increase in quarterly rates is proposed.

2. 209-6 C - Rates and Charges shall hereafter provide as follows:

RATES FOR METERED WATER

<u>Quantity Used</u>	<u>Charges Per Thousand Gallons</u>
Minimum charge per quarter up to 5,000 gallons.	\$ 33.00
5,001 gallons to 50,000 gallons per quarter.	\$ 33.00 plus \$3.04 per 1,000 gallons over 5,000 gallons.
50,001 gallons to 100,000 gallons per quarter	\$ 170.00 plus \$2.64 per 1,000 gallons over 50,000 gallons.
100,001 gallons to 1,000,000 gallons	\$301.97 plus \$2.03 per 1,000 gallons Over 100,000 gallons.
Over 1,000,001 gallons	\$2,125.23 plus \$1.62 per 1,000 gallons over 1,000,000 gallons.

3. This ordinance is deemed separable. If any part is declared invalid by a Court of competent jurisdiction, the rest and remainder shall remain in full force and effect.

4. This ordinance shall take effect upon passage and publication as provided by law.

#### CERTIFICATION

NOTICE is hereby given that the above Ordinance was introduced and passed on first reading of the meeting of the Mayor and Council of the Borough of Hamburg, held on Monday, May 6, 2013 and will be considered for final passage at a regular meeting of the Mayor and Council to be held on Monday, June 3, 2013 at 7:30 p.m. or as soon thereafter as same can be considered in the Municipal Building, 16 Wallkill Avenue, Hamburg, New Jersey at which time and place all persons interested therein or affected thereby will be given an opportunity to be heard concerning the same.
