SANITATION REPORT

- 1. Inspector gives out the sheets for the January through June State Statistics and explains the symptoms of a rabid animal.
- 2. 12 Prospect Avenue A report of a dog bite, the animal was quarantined and released.
- **3.** Hurricane Irene In the aftermath and power outages from Hurricane Irene the county did facility checks in the food establishments to make sure that no food was compromised due to the power outage.
- **4.** Fairways at Wallkill They have no pool approval as of yet but are close. They are getting all the required safety equipment and they plan on opening the pool next year.
- 5. 19 Wallkill Avenue Public Health Tennant was flooded out after Hurricane Irene, inspector went to residence with zoning officer and construction official. There was work being done on the building and all the tenants belongings were on the ground outside drying. The apartment was a mess and all the damage did not appear to be recent from the storm. The landlord was contacted, due time constraints by the landlord rental assistance was notified and the tenant was relocated to another location. No further action required at this time.
- **6.** Notification the Brothers Pizza in Governor Haines is now operating under the name of Nino's pizza. Zoning will be advised to have the owner fill out a zoning permit so there are records of new businesses coming into town. Inspector

- advises that the situation there is that the business was under two brothers; one brother left, the other is taking over and changed the name but the one brother there was always part of the ownership.
- 7. Inspector advises that Doc's is in need of a re-inspection and he will go with the fire official William Walsh, at the same time an inspection will be done for Granny's and Sunoco.
- **8.** Council Liason Mark Sena discusses the method that the county uses in determining where, when and what type of mosquito testing gets done. Inspector advises that there are reports which show that information through sampling. Also advises that that information can be found on the county website. Joe will bring the information on the sampling to the next meeting for the board to see.
