Discussion on water rates

Mayor Marino stated he was going to mention doing a modest increase for water rates at the next budget meeting, stating the town has a lot going on with the tanks needing to be repaired and painted and doing all the water meter replacements. The NANO grant will help us out also but it will be good to have a slight cushion. Mayor will give an update after the next budget meeting that will take place in January.

Memo from Regina Flammer re: billing

Regina Flammer would like to estimate the next quarter billing for the town. With the new meters going in, the system on her computer will not have all the readings inputted for the new meters and the old meters. This way, all residents will be estimated and when installations have been completed, bills will return to actual billings.

Kathy advised that water bills and tax bills, beginning in January, will be able to be paid on line via MuniciPay. A notice will be placed in the newsletter also.
