Motion by Vinnie Busteed, seconded by Bob Krysiak to open the meeting to Individual Cases. All members present in favor.

Individual Cases

Askin & Hooker, LLC for SMS V LLC - request for 40 EDUs

Attorney Bill Askin, representing property owner Steven Zangrilli of SJZ, LLC, attended to request 40 EDUs for a housing project on the Zangrilli property located on Block 36, Lot 2, 98 Route 23 North. Mr. Askin disclosed to the Board that a new developer, SMS V, LLC, is proposing to construct residential housing with a total of 40 units in all. Once the project receives the approval of allocation, a formal application will be made to the Land Use Board.

Motion by Bob Krysiak, seconded by Pat Berado to give 40 EDUs to Block 36, Lot 2 98 Route 23 North with Council approval. All members present in favor.

John Ruschke prepared a formal resolution that will go before the Mayor and Council for final approval for the 40 EDUs.

Sewer flows - February 2023

John Perry relayed the flows are very low and have stayed low for the past few months. He will do a spreadsheet between the water flows and sewer flows for comparison.

Lime Kiln Sewer Station - Discussion on estimate to rebuild/reseal

Pump Station cleaning

Alec Yanish discussed the Sewer Station Cleaning of all five stations. This action is long overdue and should be performed 2-3 times a year on the stations. Alec received one quote from Tam Enterprises – Estimate #4712- which comes to approximately \$7335.00. Two non-responsive quotes were also received. Motion by Vinnie Busteed, seconded by Pat Berado to have Tam Enterprises, 114 Hartley Road, Goshen NY 10924, perform the Sewer Station Cleaning of all five stations in the Borough at a cost not to exceed \$8,000.00. All members present were in favor.
