Nelson presents the Land Use map which will need to be revised to reflect the proposed zoning for properties along the Route 23 and Route corridors including the Highway Commercial Zone and Residential Office Zone. Krasnomowitz agrees to continue the discussion on the reexamination report since the revisions required to be made to the Land Use Map are minor,

The proposed Land Use Plan with the inclusion of the R1 and R2 (formerly RR) zones presents a more realistic approach to development of vacant lands that have environmental constraints.

Nelson and Kienz discuss the need for the Borough to adopt the Housing Plan Element and Land Use Plan in order for the Borough to have valid zoning. Since the Housing Plan Element is already in draft form from the recent COAH litigation, the Board agrees to address the Housing Plan Element with the Master Plan Reexamination Report at the June public hearing.
