Mr. Bob and Betty Allen presented a painting of the Gingerbread Castle to the Borough. Councilman Barr was honored at a luncheon for the historical work he has done in the town and county – the street signs, historic markers, and historic ordinance to name a few - and was given the picture there by The Allen's. Mr. Allen gave a brief history of how they came to reside here in 1938

and how he was a member of the Fire Dept. 1. FINANCE / TAX DEPARTMENT

1. BOARD OF EDUCATION

Councilman Garrett informed the Council that the Board of Education purchased a lawnmower at a cost of \$15,000.00 and will now hire someone to mow as the costs for the landscaping company rose drastically. The budget for the school passed with a vote of 3 out of the 5 attended.

Council received a request for a donation for the 2013 Hamburg Elementary School Yearbook Advertisement. Motion by Councilman Garrett, seconded by Councilman Barr to donate \$250.00 for the full page ad for the 2013 Hamburg Elementary School Yearbook. All in favor.

COUNCILWOMAN OEHLER:

2. RECREATION

Councilwoman Oehler stated that the Recreation Commission will be buying a refrigerator for the pavilion at the fields. They have a Family Fun Night scheduled at the YMCA on April 6th from 6-8 PM, with ages up to 11 years swimming from 6-7 PM and 12 and older swimming from 7-8 PM. Snacks will be provided. Councilwoman Oehler discussed with the Council the Senior Citizen Award. The Rec Commission presented a female name and the Council was given a male name. She inquired how they wanted to proceed. After a brief discussion, Council decided to have a male and female senior citizen of the year.

Construction Report January 1, 2013 – January 31, 2012

Councilmember Krasnomowitz advised that there were 10 permits issued, 0 certificates of occupancy, and 12 certificates of approvals with a total of \$4825.00 collected in fees for the month of January.

3. LAND USE BOARD

The Land Use Board has the 7-Eleven application coming before them, of which the BPW just approved one EDU.

4. INSURANCE

Councilman Krasnomowitz informed the Council that the Borough received an award from Statewide Insurance for improving their Loss/Ratio for the past year, which equals lower premiums for the town. A plaque was received from them for this great accomplishment.

COUNCILMAN BARR

1. FIRE COMMISSIONER / OEM

The Fire Dept. submitted a Parade Schedule for 2013 for which they would like to take the chief's vehicle and either a pumper or rescue truck out of town to the parade. The list includes: Saint Patrick's Day - March 16th in Newton; Memorial Day - May 27th at North Church Cemetery; Port Jervis - July 13th in Port Jervis, NY; and County Firemen's- October 5th, rain date of October 6th in Franklin.

2. POLICE COMMISSIONER

Monthly Report February 2013

The February 2013 monthly report for the Police Department showed 324 calls of service, including 9 arrests, 16 motor vehicle accidents, and 69 motor vehicle summonses issued.

Director Yahm stated that they did a review of their computer and operating systems. The high band / repeaters are in poor shape and the server is on a 2000 system. He got a server at no cost and it will be approximately \$2300.00 to install.

There are still issues with the Spillman System, but they are on the county level.

The MDT's in the cars are very old and are having issues with them, along with radar issues also due to them being aged.

Director Yahm said there were frozen pipes in the basement, but the DPW repaired them and then also painted.

When asked about the traffic control for the work on Rt. 23, Director Yahm said that he has not received any notification, but will try to find out.

3. HISTORIC COMMISION / HISTORIC SOCIETY

Councilman Barr discussed with the Council the Hamburg Park and Recreation Field Plaque. All members were given a sample of what the plaque would look like and say. This will be attached to the large rock from The Bluffs that we already have. Councilman Barr stated that the plaque made of bronze would cost approximately \$2300.00 and would match the other plaques in town. Mayor Marino stated that he would like to see the bronze as this park took 17 years to complete. It could also be done in aluminum for a cost of \$800.00.

Motion by Councilman Law, seconded by Councilwoman Oehler to open the meeting to the public for any questions or comments they might have with regard to the good and welfare with the Borough. All in favor.

Pamela Crum – speaking on behalf of Dot Kays, 11 Rt. 23 – received a violation notice regarding a retaining wall that was erected 10-15 years ago that has now fallen, and they cannot remember the original contractor. It was relayed to them that the town would pay to repair the wall since it was damaged by a state truck when the intersection was being redone – the State put up the wall and the State hit the wall. Councilman Barr spoke to the church; there are also some other avenues that are being looked into. Mayor Marino suggested that the town may repair the wall and if so, put a lien on the property. Ms. Crum had no problem with that. Council will continue with discussion.

Jeff Carroll – 20 Bluffs Court – inquired about the meeting that is held on the 3rd Wednesday of the month, as he wanted to attend the February 18th meeting and there was no one here. He was answered that the second meeting of the month is scheduled in case the Council does need to meet, but it is optional and a notice will be placed on the door should it be cancelled. He also stated that a

crossing guard was "watching the wall" on Linwood Ave, but no kids cross there.

Alicia Ferrante – Republican Candidate- introduced herself to the Council, stating that she was running for Sussex County Surrogate, is an attorney in Newton for 16 years. She stated that she is running as she believes voters need a choice and she believes she could do a good job.

John Haig – Linwood Ave – complained about the parking on Linwood Ave, stating that the employees of the school are parking in front of the homes there, even though there is parking in the lots. When asked if he has approached the Board of Education about this matter, he answered no. Councilman Barr responded that he needed to start there first.
