Borough Clerk Doreen Schott administered the Oath of Office of Police Sergeant to Jason Tangorra who then thanked the Mayor and Council.

INTRODUCTION OF BUDGET

Motion by Councilman Barr, seconded by Councilman Law to open the meeting to Mr. William Schroeder and CFO Army Maronpot to present the Mayor and Council the 2016 Budget for discussion and introduction. All in favor.

Mr. Schroder stated that with this budget, taxes will go up two tax points, or \$2.50 a month - \$30.00 a year per \$151,700.00 per assessed valuation.

Mayor Marino added that the Borough wanted to buy a fire truck for approximately \$400,000.00 and the new police car would come out of the budget. The Police Dept. would also like to hire a 9th officer, costing \$53,000.00 plus \$20,000.00 in benefits.

Councilman Sena said there has been a significant change in the Police Dept. salaries, changing the budget and he would like to hold off on any new hire at this time. Councilman Barr added that if we have to raise the police budget to cover this, we should. A 9th officer was agreed to be hired a year ago to handle the problems in town and interviews are still going on. Discussion to maybe hire in the last half of the year, and the last quarter of the year, to maybe next year took place due to the budgetary concerns.

Motion by Councilman Barr, seconded by Councilman Burd to hire a 9th police officer as of July 1, 2016. Councilman Sena stated that this will mean raising the budget by at least \$32,500.00.

Monthly report February 2016

The February 2016 monthly report for the Police Department showed 1057 calls of service, including 12 arrests, 11 motor vehicle accidents, and 94 motor vehicle summonses issued (ETickets – 94, hard copies – 0).

Director Yahm thanked the Council for their support. He is moving ahead with the purchase of the car, trading in car #4, purchased in 2012, and stated the motor will not make it to the dealer but will have to be towed. This purchase has been accounted for in the budget.

Mr. Yahm said he also addressed the issue of idling of the cars with the officers. Councilman Garrett asked if the officers need CEUs and Mr. Yahm responded that they need the mandated training classes, with a lot of them being available on NJ Learn. But, there is some training that cannot be taken on the computer and the officers do have to go to class, so there will be some overtime involved. Mr. Yahm is also looking for a grant for the cameras.

Board member Matt Christy, who did the presentation on the communications survey, only received 84 returns and the results of the survey were as being "average".

Councilman Law discussed the court house and the need for the front door to be replaced. Currently there is a handle and lock on the door which could be a safety issue. This needs to be replaced with a security bar handle on it. It will also help reduce the amount of police manpower needed on court night. Although no numbers have been received, it will be costly.

Councilman Garrett presented the Interlocal Agreement for 2016 Street Sweeping Contract with Hardyston Township.

2016 Landscaping Services

Councilman Garrett stated that he received two quotes and one non-responsive for the landscaping services for this year. Both proposals were similar, covering the three areas: Orchard Street /Rt. 23 / clock tower, turf care for Hamburg Fields, and the Borough Hall building. Councilman Garrett recommended going with A Way to Keep it Green, LLC, who came in at a little under \$1000.00 under the other proposal.

Motion by Councilman Garrett, seconded by Councilman Barr to accept the proposal from A Way to Keep it Green, LLC for Orchard Street, Rt. 23 Parking Lot & Clock Tower for the spring cleanup, bi-weekly weed control, fall cleanup, and cutbacks in the amount of \$4500.00; for the Recreation Field Lawn Maintenance and Aeration in the amount of \$5000.00; and for the 3 season annual change out and maintenance of the Municipal Building in the amount of \$2400.00. Councilman Sena asked when the park was going to be opened as the weather is nice, we have a new playground for the kids to use and a walking path for people to take advantage of. This will be discussed with the Road Dept. Foreman under the Public Portion.

Mike Schneider – Road Dept. Foreman – stated that he usually opens the park on April 1st and the fields are still wet right now, relaying his concern for the fields to get torn up. Councilman Krasnomowitz asked if a sign could be placed on the baseball and soccer fields stating they are closed, but liked the idea that the public could use the playground and walking path. Mr. Schneider said that the park would be open tomorrow morning (Tuesday, March 8th). He also informed the Council that the Police close the gates at sundown.

Jamie McCurry – Fire Chief – relayed that the check from Firehouse Subs would be coming in this week. He also said the department would be taking the rescue truck and chief's car to their store in Totowa for the presentation but a date has not been set yet. Mayor Marino said that since the check would not be accepted until the April's meeting, the equipment should not be shipped yet.

Joyce Oehler – EMS Captain – informed the Council that she is able to purchase defibulators at a half price cost and wondered if the Council would be interested. She said they cost between \$3-5000.00 each. After discussion, Council agreed that it would be a good idea to have one in town hall and one in the fire department. Ms. Oehler will look further into it.
