#### COAH

Councilmember Krasnomowitz advises that this resolution presented shows that the town supports the professionals in their professional determination of what Hamburg's obligation should be. Council confirms that a housing plan was previously submitted. Mayor advises that COAH has come to us with areas that are not built out as areas that may be considered, we argue that the case stating that we have existing compliance and that Hamburg is 98% developed also we need to take into consideration water sewer allocation for any new building. We are hoping the judge will accept our plan. The State came to us with two plans; one showing 47 new affordable units and another with over 100 unites. We went with the plan for 47. Mayor further advises that this has been a great expense to all towns and counties and everyone is going through the same process right now. We have the hope that our plan will be accepted, and that further cost will be limited.

Mayor Marino advises that he is trying to get more members for the Land Use Board and may have appointments at the April 4<sup>th</sup> meeting.
