MINUTES OF THE REGULAR MEETING OF THE MAYOR AND COUNCIL OF THE BOROUGH OF HAMBURG HELD ON JUNE 20, 2016 AT THE MUNICIPAL BUILDING, 16 WALLKILL AVE., HAMBURG, NJ

Extend Liquor License Premise

Mayor and Council are in receipt of copy of application to extend license premise for Doc;s, July 23, 2016 from 8:00 AM to 2:00 AM. All paperwork is in order and there is no objection from the police department.

Motion by Councilmember Law, seconded by Councilmember Krasnomowitz. All members present in favor.

Property Maintenance Issues

Mayor and Council discuss the growing problem with regards to property maintenance (grass complaints). There are many areas in town where this is a problem most are at residences that are in stages of foreclosure. Two homes in particular 26 Fairview and 54 Summit are extremely bad and need to be addressed. The property maintenance officer did issues summons to both. The attorney for 26 Fairview has requested a postponement in court and requested discovery. Councilmember Krasnomowitz advises that last he spoke with town attorney he was going to contact the attorney for 26 Fairview. Mayor and Council consider these two properties a public health and safety issues. There have been complaints from neighbors of 26 Fairview that children play in the area, the grass is so high that a car cannot even see the children as the grass is higher than some of them. Councilmember Law questions whether he can go over and cut the grass. He is advised that for insurance reasons that would not be recommended. Members discuss having the road department cut the grass

on those two properties.

Motion by Councilmember Garrett, seconded by Councilmember Krasnomowitz authorizing the road department to cut the grass as 26 Fairview Avenue and 54 Summit for public health and safety purposes. All members present in favor.

EMS – Shared Service

Mayor Marino advises that she verbally spoke with Marianne Smith regarding the EMS Shared Service. Hardyston would like Hamburg to continue coverage through December 31, 2016.

Motion by Councilmember Krasnomowitz, seconded by Councilmember Law to continue the Shared Service Agreement with Hardyston Township providing Emergency Medical Services (EMS) through December 31, 2016 at a cost of \$15,000.00 as outlined in Resolution # 2015-51 First Aid Services Agreement Between the Township of Hardyston and the Borough of Hamburg.

Motion by Councilmember Krasnomowitz, seconded by Councilmember Law to approve the continuation of EMS services to Hardyston through December 31, 2016.

COAH

Councilmember Krasnomowitz advises that to date the borough has spent a lot of money on this. At the recent court hearing the court did not accept the findings presented by the expert witness the town hired and instead referred to the state requirements of 258 units which means that Hamburg would have to build 1200 homes to comply. The recommendations of the professionals at this point is to back out of COAH and continue forward with the Affordable House Plan with an amendments advising that the town went to court to try to comply, the court would not accept the professionals recommendations. Council discusses that the Land Use Board will be the board to adopt the Affordable Housing Plan, they may present it to the Mayor and Council for the Mayor and Council to show support of plan.

Finance Department

Mayor Marino advises that we have received a letter of resignation from Maria Mascuch, Treasurer.

Motion by Councilmember Krasnomowitz, seconded by Councilmember Law to accept the resignation with regrets. All members present in favor.

Finance Department – The following person was interviewed for position in the finance department.

Mayor Marino advises that with the resignation of Maria in the treasurer's office we interviewed an applicant prior to this meeting. This person is in the process of obtaining her CFO certification, she has municipal experience in the finance office and accounts payable, payroll, HR functions and bill lists. He advises that presently she is full time with benefits. salary is \$49,000.00. The present CFO has indicated that if the town gets a full time day person who is CFO certified she will step down from the position. Mayor discusses some financial options and after interviewing he and the members present including the present CFO feel this could be a benefit to the town.

Now therefore be it resolved that the Hamburg Borough Mayor and Council hereby cease all negotiations with regards to the Hinger v Borough of Hamburg matter.

The Fire Department is proposing in lieu of proposing LOSAP they are proposing a Clothing Allowance. Mayor Marino advises that the committee will meet first to discuss this and report back to the council.
