Mayor Marino and John Ruschke spoke about completing the paving issues in the Penny Rock area using the State Contract but since there is not enough work in the area to do this, it will not be completed at this time.

Garage Doors - EMS building 2.

Mayor Marino mentions the numerous accidents that have happened involving the garage doors at the EMS building with the ambulances and the possibility of putting in one big door. This would involve putting in a header, reconfiguring the door, etc. Mayor Marino advised of looking into obtaining prices from the garage door people who are constantly fixing the doors. This would help alleviate some of the problems with backing in the ambulances and hitting the doors.

Monthly report July 2016

The July 2016 monthly report for the Police Department showed 832 calls of service, including 5 arrests, 12 motor vehicle accidents, and 33 motor vehicle summonses issued (ETickets -33, hard copies -0).

Director Yahm informed the Council the new car is in at the dealer and will be delivered once they have received the payment. The old car has been stripped and is ready for auction. A switch for the security cameras needs to be installed in the Court so that the feed can go to the Police Station. Mr. Yahm stated there is plenty of room to add cameras to the system should the Council feels it necessary to do so. Mayor Marino mentioned that he wanted a camera at the back door to the Municipal Building, which can be done for an additional \$500.-600.00 which would cover the camera and service call. Councilman Barr would like to wait and see if more cameras are needed elsewhere before scheduling that service call. Director Yahm said the AlcoTest was back and now he is waiting for the State Police to certify. There is a need for crossing guards for the upcoming school year and a message has been placed on the sign in front of the Municipal Building. Mr. Yahm will be meeting in September with Mr. Jinks with regards to the LEAD program so that the program could start in September / October. He will have two officers on from 10 am - 5 pm for Hamburg Day to assist with parking and to be visible for the day.

Hamburg Day is scheduled for August 21st and there are vendors coming, bounce houses, a petting zoo, and the fire dept. is giving away hot dogs and soda that has been provided by the Rec Commission. The Miners baseball game was a success and all but seven tickets were sold. Chris Fitzpatrick has twelve clinics scheduled for the upcoming school year. The next meeting will be held on September 20th at 7 pm.

With regards to the garage door at the EMS building, Mayor Marino asked that Mr. Schneider contact the people that has been repairing the doors and have them come in to give an estimate of what we would like done.

Diana Goovaerts – Woodland Ave – asked about the livestock ordinance and if it could be amended. Mayor Marino asked that she gather her information, send an email to the Land Use secretary and start with that Board first. Ms. Goovaerts also asked if we could post the ordinances on line after the 1st Reading, along with the Agendas for each board. Since she is a reporter for the Herald, she does like to look at a town's website to view the agendas before a meeting. She was advised that at times the agenda will change on meeting night.

Joyce Oehler – EMS Captain – informed the Council that the defibs are scheduled for delivery on August 16th and there is also a 3 hour class that EMS members and Fire Chief Jamie McCurry will be taking (all members are welcome). Councilman Law will be covering her on the ambulance for Hamburg Day and she has already received the items to give out that day.

Ms. Oehler also informed everyone that as of tonight, Hardyston will be going 24 / 7 with St. Clare's paid ambulance service with Hamburg as the back-up crew. St. Clare's does not cover mental health transport so all members are taking notes of the calls. Mayor Marino asked if it were necessary to purchase hand held scanners so our members would know what the original call was, but Ms. Oehler stated that she already has them. Councilman Law said Hamburg is being paid by Hardyston until the end of the year.
