POLICE COMMISSIONER

Mayor Marino reads the September 2016 Police Report into the record: Call for service – 826, total arrests – 7, motor vehicle accidents – 8, motor vehicle summons – 38, occurrences/ incidents – 64, walk-ins – 72, correspondence – 107

COUNCILMAN KRASNOMOWITZ CONSTRUCTION DEPARTMENT

Monthly report for August 2016 – 19 Permits issues, 2 Certificate of Occupancy, 23 Certificate of Approval. Total fees collected \$2,027.00

LAND USE BOARD/ ZONING

Councilmember Krasnomowitz discusses the email from zoning officer updating on various open property maintenance issues and advises that he discussed the complaint from Mr. O'Connor dated September 12, 2016 regarding Air Gas with the zoning officer, it was investigated and determined that there was no violation as Air Gas was not operating on the day questioned but was doing some outside maintence yard work. The zoning officer will contact Mr. O'Connor and advise him that the Mayor and Council found no issue with regards to the work Air Gas was performing on September 11, 2016.

INSURANCE

Mayor and Council are in receipt of report from Statewide Insurance: (Safety Meeting) held on September 9, 2016. August 25th visit include Police Director, DPW Foremen, Clerk, Risk Manager and Statewide Edge representative. No issues were reported.

COUNCILMAN BURD BOARD OF EDUCATION

Councilmember Burd advises that the school will be using surplus monies from last year to balance the budget next year. An architectural firm will look at the old section of the school (presently being utilized by the Board of Education) with regards to window replacement, draft issues and prepare a report on findings. One parent at the recent meeting expressed concerns that they would rather see the money for this spent otherwise in the school, possibly putting air conditioning in.

COUNCILMAN LAW COURT

Councilmember Law advises that the borough has received its first payment since the implementation of the collection services sending out letters for fines. The case was from 14 years ago and \$800.00 was paid. He also updates on the use of the credit card machine in the court house and reports that many people were very receptive to the idea of having it available as they could make payment immediately.

FIRE COMMISSIONER AND OEM

Fire and EMS Report August 2016

EMS: 1 stand by; 2 cancelled en-route; Mutual Aid - 1 Sussex.

COUNCILMAN GARRETT BUILDING AND GROUNDS

Councilmember Garrett discusses the paving to be done by Hank Sanders in front of the Fire Department and advises that it will done prior to the General Election date.

EMS Building - reports that the road department painted lines in front of the EMS building and reports that it is a great help with regards to pulling the rigs in and out.

Fire Department Kitchen- reports that there was an incident with the vent in the kitchen where the gas had to be shut off due to too much heat the vents burnt out. The department has an industrial stove that does not get used every day which attributes to the problem. Councilmember Garrett advises that to correct this they will install a lock on the thermostat.

BOARD OF PUBLIC WORKS

The Board of Public Works meeting will be held one week early on November 2, 2016 due to the schedule for water turn –off. This will give anyone on the turn off list the opportunity to come before the board.

COUNCILMAN SENA ROAD DEPARTMENT

Councilmember Sena advises that the road department is in good shape with regards to salt; they have 200 + tons on hand and ordered another 150. He thanks the road department for the great job they did with the prep for the micro paving project. There was extensive prep work including rebuilding 6 catch basins and some asphalt replacement on Hamilton.

RECREATION

Councilmember Sena advises that at the September Recreation meeting Stephanie Jasper (Mountains of Murals) attended and discussed the possibility of using the Hamburg Park for a weekend long festival they are planning for next year. She was advised to contact the Hamburg Fire Department for the Pavilion as the town does not permit the renting of the park for private use.

Trunk or Treat will be held on October 29, 2016; 1:00 PM at the Hamburg Park.

Littell Center Joint Meeting scheduled for October 20, 2016 which Councilmember Sena will attend.

Councilmember Garrett advises that he was approached recently on ways he thought the governing body could promote or "Market Hamburg" as a place for people to consider residing; especially given the large foreclosure and vacant homes we are seeing in town. Councilmember Krasnomowitz advises that that is what Newton is trying to do, they have hired a marketing agency to promote business, possibly utilize the website, having events such as festivals that bring in people from outside the area would also help.

Jacquie Espinoza – JCPL advises that JCPL is opening another Power Institute Session in Monmouth County at Raritan College. This is a great opportunity for anyone who likes to work outside, a 2 year degree that is paid for and a great career opportunity. She also advises that Nelson Tree Service will be in the area doing cutting maintenance on the distribution lines.
