Monthly report October 2016

Monthly report for October

increase will be offered.

The October 2016 monthly report for the Police Department showed 920 calls of service, including 3 arrests, 19 motor vehicle accidents, and 49 motor vehicle summonses issued (ETickets - 49, hard copies - 0).

Director Yahm stated the LEAD program at the Hamburg School will start again in December and run for 16 weeks, ending in May 2017. Sergeant Barzca did a Halloween presentation at the school which went over great with the kids.

The radio antenna had to be fixed at a cost of \$5000.00, along with the repeater, at no cost, but this was included in the police budget. Northeast Communications is the company that was called to make the

Mr. Yahm applied for the COPS grant for the money for another officer but did not make the 1st wave of approved applications. He is hopeful for approval on the 2nd and final cut.

With respect to the crossing guards, Mr. Yahm has received more applications, with 3-4 people with backgrounds pending. He is also hopeful with the new pay upgrade that this will be helpful. There is a new bail procedure and our officers are 100% compliant. Councilman Law mentioned the Judge and Court Administrator as being compliant with training but Mr. Yahm was unsure if they were. Ms. Coan will most likely need to purchase an IPad for bench warrants, etc.

Councilman Sena discussed the crossing guard pay. Discussion entailed comparing the daily rate of a guard and the head guard with other towns. After some discussion and wanting to bring the pay comparable, an

Motion by Councilman Garrett, seconded by Councilman Sena to close to Director Yahm. All in favor.

Motion by Councilman Sena, seconded by Councilman Garrett to raise the pay for crossing guards to \$13.00 a session, with the head guard receiving \$15.00 per session, effective immediately. All in favor.

Recommendation: Crossing Guard Position - Stacy Reardon. Background check complete. An application was received from Stacy Reardon for a crossing guard position. Her background and medical have been completed and are acceptable.

COUNCILMAN GARRETT

BUILDING AND GROUNDS

Councilman Garrett stated that the paving in front of the Fire Dept. is done and looks great. The Road Dept. also did line stripping in front of the bay doors by EMS which is helpful in backing up the ambulances.

Councilman Garrett said he would be looking into the bills for the port-a potty at the rec fields and the cleaning company for the Borough buildings as they seemed high.

BOARD OF PUBLIC WORKS

Recommendation from BPW Extend Versa Probe Warranty December 2016 through November 2017. Cost \$403.00.

Councilman Garrett presented a recommendation from the BPW for the extended warranty from Northrop Grumman for the VersaProbe equipment that is used with reading the Badger meters is due for renewal at a cost of \$403.00, which would cover the warranty period of December 2016 thru November 2017. Motion by Councilman Garrett, seconded by Councilman Law to accept the recommendation of the BPW for the VersaProbe warranty at \$403.00 to cover the warranty period of December 2016 thru November 2017. All in favor.

Councilman Garrett said we are in a drought warning now, meaning the DEP has the authority to monitor and direct utilities where to "feed" water. Hamburg is in good shape as we are ground water (due to our wells) and not surface water (reservoirs).

The generator for the booster station should be ready within the next month.

COUNCILMAN SENA

FINANCE / TAX DEPARTMENT

The Tax Collector's report for September showed a total of \$244,947.34 being collected.

Motion by Councilman Sena, seconded by Councilman Garrett to accept the resolution to refund for water and sewer for 124 Heritage Lane in the amount of \$245.87. All in favor. ROAD DEPARTMENT

The Road Dept. continues to pick up leaves and grass on Monday and Friday and sometimes every day as there is so much of it; this will terminate at the end of November. The sanders and plows are ready also for the winter.

Councilman Burd asked about the micro paving in Penny Rock, saying that he received a lot of bad feedback about it. Mayor Marino also stated that it was not as he expected but was advised that it will look better as time goes. There was concern mentioned about when the plows hit it in the winter and wondered how the road would hold up.

BOARD of HEALTH 3.

The Board of Health meeting was held on October 11th without County representation. A rabies clinic will not be held this year in Hamburg.

Ms. Espinosa added that she will look further into the matter.

Mike Schneider - Road Dept. Foreman - Mayor Marino asked Mr. Schneider if he knew the micro paving in Penny Rock was going to be as it is. Mr. Schneider replied that he did not, but that Hardyston is considering doing the same thing also.

Councilman Krasnomowitz asked Mr. Schneider about the water on Edsall Street and it has been there for some time now. Mike Schneider replied that it is a service leak and is hoping to get it repaired before winter.
