Mr. William Schroeder, Nisivoccia and Company, Dawn Babcock, CFO and Christine Licata, Treasurer will present the Mayor and Council with the 2017 Budget for discussion and adoption.

Mayor Marino added some of the increases came from the pensions and benefits even though some of those costs are picked up by the employees. He also added a lot of work goes into the budget and thanked everyone.

#### Opening of Rec Fields / Port-A-Potty

Mike Schneider would like to open the fields in a week or two since the weather has been so nice, so the port-a-potty will also have to be delivered.

#### 2. ROAD DEPARTMENT

The Road Dept. looked at the issue on the sidewalk by the Post Office and have taken care of it temporarily but Councilman Sena stated that John Ruschke will have to take a look at it as perhaps there may be problems due to landscaping issues ie: tree stumps, etc.

The sink hole problem on Rt. 23 by Winding Brook is still an issue but possibly with the gas tax in effect, there may be money available for the State to repair.

A large salt purchase was just made so the Road Dept. is prepared for the weather.

#### 3. BOARD of HEALTH

The animal licensing is around 45 dog licenses behind from last year at this time. The next meeting will be in April.

#### 4. RECREATION

Recreation has a Family Swim night at the YMCA planned for this coming Saturday, March 11th from 6-8 pm for Hamburg residents. There are approximately 35 registered so far.

comfortable and since it was voluntary, it was ok by the Council.
