### **Golf Social**

Board discusses holding the twilight golf social at the Sky View Golf Club in Sparta. There will be a \$40.00 registration fee, which will also include the range for practice and the cart. There was a concern that it would affect the golf outing the fire dept. holds but Dan assured them that it would not. Board decides on Friday, August 6<sup>th</sup>. The cost will be \$30.00 a head with a \$10.00 profit. A total of 20 people would be needed to recover the money that recreation will be dispersing, which is a non-refundable \$500.00 deposit to reserve the date and cover the golf carts. Kathy will run off flyers to be included in the June water bill and advertise on tv and in the paper.

Motion by Laura McCann, seconded by Chris Fitzpatrick to spend \$500.00 for a non-refundable deposit for a golf outing at Sky View Golf Club for a golf social on August 6<sup>th</sup>. All in favor.
