### Liz Jackson - NJ Fish and Wildlife

Ms. Jackson presented a program entitled "Hooked on Fishing – Not on Drugs" to members. This is a program in which a free 2 day training program is set up for adults to learn how to set up our own program so that it works for Hamburg. Liz will supply the resource tools to make it work. The targeted age would be school aged and high school kids. Fishing gear would be accessible and Liz also knows that there are ways to have trips paid by other groups and agencies. Anyone over the age of 16 needs a license. A good place to start would be Hamburg Day, to hand out the pamphlets with a registration sign-up sheet. Parents must be involved as this would not be a babysitting service. The program would take place during the 2014 school year. Liz will help with providing guidelines and decisions on how many events must be attended.

Motion by Chris Fitzpatrick, seconded by Joyce Oehler to hand out the pamphlets at Hamburg Day, with a registration sign-up sheet for this to take place during the 2014 school year with parents' involved. All in favor.

Liz Jackson also relayed that members needed to decide when and where to meet, make up a flyer for the program, and that registration will be on a first come first serve basis and put a limit on it, so that it is a comfortable size group to work with. She also suggested having a waiting list on hand in case someone should change their mind. Members asked about liability on the town and Mr. Clemack will be contacted but all involved will be asked to sign a waiver.

Members thank Liz for her time.
