

AN ORDINANCE AMENDING CHAPTER 209 -
WATER - OF THE CODE OF THE BOROUGH
OF HAMBURG COUNTY OF SUSSEX, STATE
OF NEW JERSEY TO MODIFY WATER RATES

Ordinance #09-2011

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 209 - WATER - of the Code of the Borough of Hamburg, is amended as follows:

1. Statement of Purpose: Water rates have not increased for approximately twenty (20) years while the costs of maintaining and improving the water system continue to increase. Revenues under the existing rates system are not sufficient to cover costs. Accordingly, a five per cent increase in quarterly rates is proposed.

2. 209-6 C - Rates and Charges shall hereafter provide as follows:

RATES FOR METERED WATER

<u>Quantity Used</u>	<u>Charges Per Thousand Gallons</u>
Minimum charge per quarter up to 5,000 gallons.	\$ 29.93
5,001 gallons to 50,000 gallons per quarter.	\$ 29.93 plus \$2.76 per thousand gallons over 5,000 gallons.
50,0001 gallons to 100,000 gallons per quarter	\$ 154.13 plus \$2.39 per 1,000 gallons over 50,000 gallons.
100,001 gallons to 1,000,000 gallons	\$273.63 plus \$1.84 per 1,000 gallons Over 100,000 gallons.

Over 1,000,001 gallons


\$1,929.63 plus \$1.47 per
1,000 gallons over 1,000,000
gallons.

3. This ordinance is deemed separable. If any part is declared invalid by a Court of competent jurisdiction, the rest and remainder shall remain in full force and effect.

4. This ordinance shall take effect upon passage and publication as provided by law.
