AN ORDINANCE AMENDING CHAPTER 209 - WATER - OF THE CODE OF THE BOROUGH OF HAMBURG COUNTY OF SUSSEX, STATE OF NEW JERSEY TO MODIFY WATER RATES

Ordinance #06-2012

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 209 - WATER - of the Code of the Borough of Hamburg, is amended as follows:

- 1. Statement of Purpose: Revenues under the existing rates system are not sufficient to cover costs. Accordingly, a five per cent increase in quarterly rates is proposed.
 - 2. 209-6 C Rates and Charges shall hereafter provide as follows:

RATES FOR METERED WATER

Quantity Used	<u>Charges Per Thousand</u> <u>Gallons</u>
Minimum charge per quarter up to 5,000 gallons.	\$ 31.43
5,001 gallons to 50,000 gallons per quarter.	\$ 31.43 plus \$2.90 per thousand gallons over 5,000 gallons.
50,0001 gallons to 100,000 gallons per quarter	\$ 161.91 plus \$2.51 per 1,000 gallons over 50,000 gallons.
100,001 gallons to 1,000,000 gallons	\$287.59 plus \$1.93 per 1,000 gallons Over 100,000 gallons.
Over 1,000,001 gallons	\$2,024.03 plus \$1.54 per 1,000 gallons over 1,000,000 gallons.

- 3. This ordinance is deemed separable. If any part is declared invalid by a Court of competent jurisdiction, the rest and remainder shall remain in full force and effect.
- 4. This ordinance shall take effect upon passage and publication as provided by law.
