## AN ORDINANCE AMENDING CHAPTER 164 -SEWERS - OF THE CODE OF THE BOROUGH OF HAMBURG COUNTY OF SUSSEX, STATE OF NEW JERSEY TO MODIFY SEWER USER FEES

## Ordinance #07-2012

BE IT ORDAINED, by the Mayor and Council of the Borough of Hamburg, in the County of Sussex, State of New Jersey, that Chapter 164 - SEWERS - of the Code of the Borough of Hamburg, is amended as follows:

- 1. Statement of Purpose: Revenues under the existing rates system are not sufficient to cover costs. Accordingly, a five per cent increase in quarterly rates is proposed. The senior citizen credit of \$15.00 per quarter shall continue.
- 2. Section 164-64. Charges and Fees. is hereby amended in its entirety to provide as follows:
- A. The following charges and fees for connection and for use of the local sewerage system and the SCMUA sewage treatment plant are hereby fixed and/or prescribed and the Borough shall charge same to the user and the user shall pay such to the Borough on a quarterly basis. For the purpose of this section, the quarterly periods shall be calendar quarters. There shall be a charge of \$170.89 per quarter for equivalent single-family dwelling units (EDU) effective June 01, 2012.
  - B. Where at least one of the owners of a single-family dwelling or multifamily dwelling unit is at least 65 years of age and the premises have been granted a senior citizen real estate deduction pursuant to N.J.S.A. 54:4-8.41 by the Hamburg Tax Collector, then the charge for an equivalent unit shall be \$155.89 per quarter effective June 01, 2012.
- 3. This ordinance is deemed separable. If any part is declared invalid by a Court of competent jurisdiction, the rest and remainder shall remain in full force and effect.
- 4. This ordinance shall take effect upon passage and publication as provided by law.
